## **Lorado Mill Photo Contest Rules**



Official Contest Rules for the Lorado Mill Photo Contest (the "Contest") offered by the Saskatchewan Research Council ("SRC"). The Contest gives you a chance to win the prize(s) described in these Contest rules (the "Rules"). The Contest will run from July 12, 2021 until September 30, 2021 (the "Contest Period").

BY ENTERING THE CONTEST, AN ENTRANT REPRESENTS THAT HE OR SHE SATISFIES ALL OF THE ELIGIBILITY REQUIREMENTS SET FORTH IN THESE RULES AND AGREES TO BE BOUND UNCONDITIONALLY BY THESE RULES AND ALL DECISIONS OF SRC, WHICH ARE FINAL AND BINDING WITH RESPECT TO ALL MATTERS RELATING TO THE CONTEST.

- 1. **Participation**: Entry into this Contest is free and does not require any purchase. During the Contest Period, entrants can submit up to 5 original photographs (the "Photo") by (i) emailing the Photo to cleans@src.sk.ca, along with the contest entry form available at src.nu/loradocontestform. If you cannot email the photos, you can contact a member of the Project CLEANS team at cleans@src.sk.ca to arrange another way to submit your photos with your entry form. Entrants can also contact cleans@src.sk.ca to be sent the contest entry form. All contest participants must fill out an entry 5. **Prize Winners:** Three winners will be randomly drawn from and include it with their photos.
- 2. **Photo Requirement:** To be eligible for the Contest, the Photo must meet the following requirements: (i) the Photo must be taken at the Former Lorado Mill Site, (ii) (iii) entrants must have completed the contest entry form, (iv) the Photo must have been taken between 2017 and 2021, (v) the Photo must not have been entered into another SRC contest, and (vi) the Photo needs to be 7. - the Photo must be an original and belong to the entrant, 6. Eligibility: The Contest is open only to residents of the Athabasca Basin. Entrants must have reached the age of majority in the province or territory in which they reside to enter.
